**ORDER APPROVING THE RECEIVER’S FIRST DYKEMA FEE APPLICATION**

BEFORE THE COURT is The Receiver’s First Dykema Fee Application in the above action. The Court first notes the daunting challenge that Dykema Gossett PLLC (“Dykema”) confronted in undertaking the representation of the Receiver during a critical stage in the litigation.
