January 6, 2011, to ensure that Movant had indeed attended his appointment, and was

informed by Dr. Ingram that he had (See Attachment).

5) Undersigned Counsel paid for the forgoing referral appointment out of his pocket with his

In the process of setting up this appointment it was determine that the Receivership had

directly caused Baron's insurance to be canceled. Undersigned Counsel is presently

cooperating with Mr. Barry M. Golden, counsel for Peter Vogel, the Receiver in this case,

in an effort to determine what caused this lapse in Mr. Baron's insurance. Mr. Barrett and

Mr. Golden have agreed to continue cooperating in an ongoing effort to make funds available

to Jeff Baron for any and all medical purposes while his insurance is out of coverage.
