**ORDER: (A) GRANTING, IN PART, RECEIVER'S EXPEDITED APPLICATION FOR PAYMENT OF RECEIVERSHIP EXPENSES PURSUANT TO THE INTERIM ORDER [DE # 61]; AND (B) RECOMMENDING TO DISTRICT COURT THAT IT ADOPT AND ACCEPT THIS ORDER**

On February 12, 2013, the receiver, Peter S. Vogel (the "Receiver"), filed an Expedited Application for Payment of Receiver Expenses Pursuant to the Interim Order [DE # 61] (the "Expense Request"). The Expense Request asked for the following relief: (a) authority to immediately pay Mr. Matthew Morris directly 95% of the approved fees of \$54,572.50, (b) authority to immediately pay Mr. Damon Nelson, Mr. Joshua Cox, and Mr. James Eckels directly the requested aggregate fees and expenses of \$111,788.39, and (c) authority for Dykema Gossett PLLC to take

into income the funds of \$737,276.72 it is currently holding in its trust account so as to be current on fees through December 31, 2012.

On April 4, 2013, the court<sup>1</sup> held a hearing on the Expense Request. The court found good cause to grant some of the relief requested in the Expense Request. Specifically, the court found that the past due wages and expenses owed to Mr. Damon Nelson, Mr. Joshua Cox, and Mr. James Eckels (\$111,788.39 in the aggregate for June-December 2012) should be paid immediately from the res of the receivership estate. Accordingly, the bankruptcy court hereby

**ORDERS** that the Receiver shall immediately pay Mr. Damon Nelson \$83,875.00; and further

**ORDERS** that the Receiver shall immediately pay Mr. Joshua Cox \$17,213.39; and further

**ORDERS** that the Receiver shall immediately pay Mr. James Eckles \$10,700.00; and further

**ORDERS** that all other relief requested in the Expense Request shall be considered at a later point in time, as deemed appropriate by the court; and further

**RECOMMENDS** that the District Court, who jointly made the


